12. Discussion and Possible Action on updating Small Business Investment Program Guidelines (J. Landrum) Mrs. Julia Landrum presented this item for the board's consideration and review. She stated that the EDC has received feedback on the application guidelines. The hours of operation because in the guidelines it stated that Prospective businesses must be open to the public at least six (6) days a week, minimum of eight (8) hours a day, and open past 6:00 PM. The second change of the guidelines would be Franchise Retail Stores or Fast-Food Restaurants being eligible due to being local franchise owner. Mr. Jose L. Morales stated that we must be careful because successful franchises can apply so a stipulation need to be put into effect that it must be a failing business with financial need. The building must be leased and not owned as well. Mrs. Julia Landrum would like to implement that anyone who applies for the grant must be a member of the chamber or become one. Mr. Jose L. Morales then asked Mr. Mark Sossi if that is legal. Mr. Mark Sossi stated that we cannot make it mandatory.

A motion to approve EDC staff to revise the guidelines and bring back to the board for review was made by Mr. Thomas Garza. The motion was seconded by Mr. Joshua Gonzales. Upon a unanimous vote the motion carried.
