ITEM 1. WELCOME TO VISITORS.

Jose L. Morales, President, welcomed everyone and called the meeting to order at 5:30 p.m. at the Cesar Gonzalez Meeting Hall located at the Municipal Building.

ITEM 2. PLEDGE OF ALLEGIANCE TO THE U S FLAG AND TO THE TEXAS FLAG.

ITEM 6. UPDATE FROM REYNA NETWORK ON THE USDA SMALL BUSINESS LOAN PROGRAM.

Thelma Gonzalez, Project Manager from Reyna Network, briefed the Board on the activity report which covers January 15, 2018 through February 9, 2018. The EDC is estimated to have a revolving fund balance of \$214,979.38 as of January 31, 2018. Mr. Orlando Garza has been delayed with completing construction, but is planning on submitting his final permit application this week to obtain his occupancy permit to open his car wash. There are no delinquent accounts, however there are outstanding late fees.

Rachel Siller, Coordinator, presented the Downtown Rent Subsidy Grant Application from Mr. Jesus Longoria, Walk In Faith PHC, in the amount of \$4,800.00. Jose L. Morales, President, questioned if they are a religious organization. Rachel Siller clarified Walk In Faith PHC is not a religious organization, they provide in-home primary health care. They currently have 40 employees on their payroll, and are anticipating an additional 100 employees by the end of the calendar year, which fulfills the job creation aspect of the program. Martha McClain, Public Relations Director, presented information for the annual event organized by the City of San Benito Special Events Board. If granted, the funding will be utilized by the City's Public Relations Department to market the event. Jose L. Morales, President, requested verification of the status of the budget for promotional expenditures. Rachel Siller, Coordinator, indicated we are within budget, and this is a budgeted line item. ITEM 12. CONSIDERATION AND POSSIBLE ACTION ON APPROVAL OF THE SERVICE AGREEMENT BETWEEN THE CITY OF SAN BENITO AND THE SAN BENITO ECONOMIC DEVELOPMENT CORPORATION FOR UNITED STATES DEPARTMENT OF AGRICULTURE (USDA) INTERMEDIARY RELENDING PROGRAM (IRP) MANAGEMENT SERVICES.

Rachel Siller, Coordinator, presented the proposed Service Agreement for the City to provide management and financial services to the EDC for the USDA IRP program starting March 1, 2018. This Agreement will compensate the City for performing the services which were previously performed by The Reyna Network. The Service Agreement will go before the City Commission for approval on February 20, 2018. Mary Bolado, Board Member, moved to approve the Service Agreement. ITEM 13. PRESENTATION OF THE QUARTERLY INVESTMENT REPORT FOR OCTOBER 2017 THROUGH DECEMBER 2017.

Belen Pena, Finance Director, presented the investment report for the first quarter of Fiscal Year 2017-2018. Investments made throughout year are experiencing higher interest rates, therefore, are providing an increase in interest income.
