1. Determination of a quorum

Mr. Jeremy Maya made welcoming remarks. A quorum was determined to be present.

2. Call to Order;

Mr. Jeremy Maya called the meeting to order at 5:32 PM.

5. Public Comments

Mrs. Rebeca Castillo presented the Financials for the periods October 2020, November 2020, December 2020 and January 2021. There continues to be questions on the sales tax comparable analysis spreadsheets and some difference on the reports. Board requested for the EDC staff to follow up with the finance department to clarify and update the reports accordingly. A meeting with City Finance will be scheduled at which Commissioner Pedro Galvan would like to participate as well.

A motion to acknowledge the presented financials was made by Commissioner Pete Galvan. The motion was seconded by Mr. Encarnación Lopez. The motion carried unanimously.

11. Presentation and Acknowledgment of the USDA RLP report for the periods ending January 31, 2021 and February 28, 2021;

Mrs. Rebeca Castillo presented the USDA Revolving Loan Program report for the period ending January 31, 2021 and February 28, 2021.

A motion to acknowledge the USDA RLP reports for the periods ending January 31, 2021 and February 28, 2021 was made by Mr. Encarnación Lopez. The motion was seconded by Mr. Adrian Gonzalez. The motion carried unanimously.

12. Consideration and Possible Action on the FY 2020-2021 Small Business Investment Program Applications;

Mrs. Rebeca Castillo presented the application for the FY 2020-2021 Small Business Investment Program.

A motion to approve the La Casa de Las Flores Application in the amount of \$2,100.00 was made by Mr. Encarnación Lopez. The motion was seconded by Commissioner Pete Galvan. The motion carried unanimously.

13. Consideration and Possible Action on the San Benito EDC Employees Health Insurance and Dental Plan;

Mrs. Rebeca Castillo presented this Item. The health and dental insurance Premiums and Payment Breakdown was presented. Mrs. Castillo explained that the proposal was factoring a 20% increase on the EDC's contribution compared to 2020-2021 premiums. The 20% has been factored to reflect and meet affordable criteria & comparable contributions by similar employers.

A motion to approve Blue Cross Blue Shield S643ADT Health and Dental Plan effective April 1, 2021 and ending on March 31, 2022 as proposed and reflected on the agenda item documents was made by Mr. Adrian Gonzalez. The motion was seconded by Commissioner Pete Galvan. The motion carried unanimously.

14. Consideration and Possible Action on the San Benito Economic Development Corporation FY 2020-2021 Annual Budget Amendment #2

The proposed budget amendment is to increase \$56,157.00 for the following line items: Salaries \$3000, FICA \$186, Medicare \$44, Simple IRA \$90, Health & Dental Insurance \$1,823, Workers Comp \$14, Professional Services \$21,000 (\$12,000 Rio Sports Live Sponsorship, Video Production \$6,000, & Mapping Services \$3,000), & \$30,000 roofing services.

A motion to approve the San Benito Economic Development Corporation FY 2020-2021 Annual Budget Amendment #2 was made by Mr. Encarnación Lopez. The motion was seconded by Commissioner Pete Galvan. The motion carried unanimously.

15. Discussion and Possible Action on Procurement of Banking Services for the San Benito Economic Development Corporation

Discussion took place and it was determined that San Benito EDC would follow the City of San Benito with their procurement of Banking Services.

A motion to approve to follow the procurement of banking services as the City of San Benito by the San Benito Economic Development Corporation was made by Mr. Encarnación Lopez. The motion was seconded by Commissioner Pete Galvan. The motion carried unanimously.
