Motion to approve the change of Electricity Provider was made by Mr. Rene Garcia. The motion was seconded by Mr. Mario Silva. Motion carried unanimously.

11. Consideration and Possible Action on the preparation of an EDC Investment Policy by Valley View Consulting;

Motion to approve the preparation of an EDC Investment Policy by Valley View Consulting was made by Mr. Encarnacion Lopez. The motion was seconded by Mr. Rene Garcia. Motion carried unanimously.

12. Consideration and Possible Action on the 2020-2021 Health and Dental Insurance Plan for the San Benito EDC employees;

Mrs. Rebeca Castillo, EDC Executive Directors presented the 2020-2021 Health and Dental Insurance Plan for the San Benito EDC employees. Mrs. Castillo presented a spreadsheet that gives a competitive plan with Blue Cross Blue Shield S643ADT being the best option and it will be valid from April 1, 2020 to March 31, 2021. The plan has increased its monthly premium in a total of \$108.98 both employees. With \$105.50 being an increase in health insurance premium for employees and \$3.48 a month being an increase in dental insurance. The cost in the plan does not impact the cost to the employer. Do note that the plan did change where the employee's deductible for individual from \$7,900 to \$8,150 and deductive for family from \$15,800 to \$16,300 and co pay for doctor's visits increased from \$40 to \$50.

Rebeca Castillo's monthly cost increased by \$63.48 Victoria Padron's monthly cost increased by \$44.74

Motion to approve the 2020-2021 Health and Dental Insurance Plan for the San Benito EDC employees was made by Mr. Encarnacion Lopez. The motion was seconded by Mr. Mario Silva. Motion carried unanimously.

13. Consideration and Possible Action on the Procurement of Services for the installation of a sprinkler system at the EDC offices located at 701 N. Bowie Street, San Benito, TX;

Three sprinkler system quotes were presented to the EDC Board of Directors.

Motion to select Valley Wide Sprinkler Systems as the vendor to install the sprinkler system at the EDC offices was made by Mr. Rene Garcia. The motion was seconded by Mr. Encarnacion Lopez. Motion carried unanimously.

14. Consideration and Possible Action on the deferment of payments for up to six months for the US Department of Agriculture Revolving Loans recipients and extending the note up to six months past the original end of the note;

USDA is authorizing for Revolving Loan Program Administrators to defer payments for six months for our current loan recipients or new applicants. Deferment can be applied anytime between March 1, 2020 and December 31, 2020.

Motion to approve the deferment of payments for up to six months for the US Department of Agriculture Revolving Loans recipients and extending the note up to six months past the original end of the note was made Mr. Encarnacion Lopez. The motion was seconded by Mr. Jeremy Maya. Motion carried unanimously.

15. Discussion and Possible Action on an emergency assistance program in response to COVID-19;

Mrs. Rebeca Castillo presented the emergency assistance program in response to COVID-19.

Motion for Executive Director to proceed as directed was made by Mr. Rene Garcia. The motion was seconded by Mr. Encarnacion Lopez. Motion carried unanimously.

16. Consideration and Possible Action on the revision of the Small Business Investment Program;

Motion to approve was made by Mr. Encarnacion Lopez. The motion was seconded by Mr. Rene Garcia. Motion carried unanimously.

17. Consideration and Possible action on the proposed 2019-2020 Annual Budget Amendment #1;

The EDC staff has prepared and suggested increase on funding on the line items that are highlighted in yellow in order to adequately continue to undergo economic development efforts. The total amount increase in this budget amendment is of

\$361,843. There are \$13,000 of this amount that had to be programmed due to the EDC paying in March 2020 some expenses from June and September 2019 (last fiscal year). The attached proposed budget amendment has all the line items that are needing an increase of funding highlighted in yellow. The request is for the EDC to be able to program \$361,843 from the Fund balance, which based on January 2020 financials has a balance of \$2,144,429.

Fund Balance as of Jan 2020 Financials \$2,144,429

\$361,843 budget increase will be programmed from the Fund balance.

The proposed budget amendment reflects a 32.59% increase.

Marketing Line Items cannot exceed 10% of EDC programmed budget. The proposed budget amendment is within the 10% maximum allowed, that being 7.15%

Motion to approve the proposed 2019-2020 Annual Budget Amendment #1 was made by Mr. Rene Garcia. The motion was seconded by Mr. Encarnacion Lopez. Motion carried unanimously.

18. Determination of Date and Time for the next San Benito EDC Board of Directors Meeting;

Next regular meeting will be on May 27, 2020. No Action Needed.
