1. Determination of a quorum

Mr. Julian Rios made welcoming remarks and determined quorum.

2. Call to Order

5. Public Comments

6. Presentation and Acknowledgement of the San Benito EDC Financial Statements for the period ending March 31, 2022 (B. Peña)

The San Benito EDC Financial Statements for the period ending March 31, 2022 were presented by Mrs. Belen Peña, Finance Director.

A motion to approve the San Benito EDC Financial Statements for the period ending March 31, 2022 was made by Mr. Adrian Gonzalez. The motion was seconded by Mr. Encarnacion Lopez. Upon an unanimous vote the motion carried.

7. Presentation and Acknowledgement of the San Benito EDC USDA IRP Reports for the period ending April 30, 2022 (B. Peña)

The San Benito EDC USDA IRP Reports for the period ending April 30, 2022 were presented by Mrs. Belen Peña, Finance Director.

A motion to approve the San Benito EDC USDA IRP Reports for the period ending April 30, 2022 was made by Mrs. Deborah Morales. The motion was seconded by Mr. Encarnacion Lopez. Upon an unanimous vote the motion carried.

8. Consideration and Possible Action on the April 28, 2022 EDC Board of Directors Regular Meeting Minutes (K. Guerra)

The April 28, 2022 EDC Board of Directors Regular Meeting Minutes were presented for the EDC Board of Director's review and consideration.

A motion to approve the April 28, 2022 EDC Board of Directors Regular Meeting minutes was made by Commissioner Rene Garcia. The motion was seconded by Mr. Encarnacion Lopez. Upon an unanimous vote the motion carried.

9. Discussion and Possible Action on the Resaca Village Project (R. Castillo)

As per legal counsel's it was recommended that item nine (9) be moved into executive session.

A motion to move item #9 into executive session was made by Mr. Adrian Gonzalez. The motion was seconded by Mr. Encarnacion Lopez. Upon a vote of Six (6) "I's" By Mr. Julian Rios, Mr. Encarnacion Lopez, Commissioner Rene Garcia, Mr. Mario Silva, Mr. Jeremy, Mr. Adrian Gonzalez and 1 "Nay" by Mrs. Deborah Morales the motion carried.

After discussion in executive session a motion to deny the resaca village project request was made by Commissioner Rene Garcia. The motion was seconded by Mrs. Deborah Morales. Upon an unanimous vote the motion carried.

10. Consideration and Possible Action on the Small Business Investment Program - Rent Subsidy award for Rolling Smoke BBQ (K. Guerra)

Miss Katarina Guerra presented the Rent Subsidy Grant application for Rolling Smoke BBQ. After reviewing the application Mr. Rios mentioned that according to their stated hours of operation, they do not meet the requirements to qualify for the grant. The EDC board recommend that staff follow up with the business and recommend they open up an additional day to meet the guidelines and return the application to the board for consideration once done so. Item #10 was tabled due to Rolling Smoke BBQ not meeting the guidelines of the EDC rent subsidy program

A motion to table item #10 was made by Commissioner Rene Garcia. The motion was seconded by Mr. Julian Rios. Upon an unanimous vote the motion carried.

11. Consideration and Possible Action on the Small Business Investment Program - Rent Subsidy award for The American Dream (K. Guerra)

Miss Guerra presented the rent subsidy application for the business American Dream. Miss Guerra recommended the board table this item since the business did not meet the guidelines pertaining to hours of operation. She explained EDC staff will follow up with the business to adjust their hours of operation to qualify for the grant and return the application to the board for later approval. Item #11 was tabled due to The American Dream not meeting the guidelines of the EDC rent subsidy program.

A motion to table item #10 was made by Mr. Adrian Gonzalez. The motion was seconded by Mr. Mario Silva. Upon an unanimous vote the motion carried.

12. Consideration and Possible Action on the Downtown San Benito Art Murals Program (R. Castillo/K. Guerra)

Mrs. Rebeca Castillo presented the request for artist document and the guidelines & application for the Downtown San Benito Murals Program. She explained that the guidelines and application have already been reviewed by the Downtown Committee and recommend that EDC Board approve the documents to begin the program. She also explained that money in the budget has already been programmed for these efforts and requires no budget amendment. The program would allow either the business owner with a possible location or the artist to submit the application to request for funds.

The motion to approve this item was made by Mr. Adrian Gonzalez. The motion was seconded by Commissioner Rene Garcia. Upon an unanimous vote the motion carried.

13. Executive Directors Report (R.Castillo)

Mrs. Rebeca Castillo presented this information. There was a small discussion in reference to the downtown development efforts/activities and other operational activities happening.
