1. Determination of a quorum;

Mr. Rene Garcia, EDC Vice President made welcoming remarks. A quorum was determined to be present.

Mrs. Belen Pena, City of San Benito Finance Director, presented the USDA RLP Report for the period ending June 30, 2021.

 Procurement of Legal Services: Presentation and Action for the selection of Attorney to provide legal services for the San Benito Economic Development Corporation;

Mrs. Rebeca Castillo, EDC Executive Director, presented this item. She stated that there were five (5) responses to the Request for Proposals and that each was going to provide a verbal presentation to supplement their written proposal and answer any questions that the EDC Board of Directors might have.

The Board asked a few questions and discussed the item. Part of the discussion included the process that was followed to seek legal counsel services. Mrs. Deborah Morales asked Mr. Sossi about the issue of serving the City and the EDC and how that could be an issue. Mr. Sossi responded that he did not consider that there was a conflict of interest and that the EDC Bylaws allowed for the EDC to procure the same attorney as the City or seek their own attorney.

A motion to approve Mark E. Sossi, Attorney at Law as the San Benito EDC's Attorney was made by Mr. Encarnacion Lopez. The motion was seconded by Mr. Mario Silva. Voting Aye: Mr. Rene Garcia, Mr. Adrian Gonzalez, Mr. Encarnacion Lopez, and Mr. Mario Silva. Voting Nay: Mrs. Deborah Morales. The motion passed.

10. Consideration and Possible Action on the San Benito EDC's annual membership renewal to the San Benito Chamber of Commerce (Presented by R. Castillo)

Mr. Rebeca Castillo, EDC Executive Director, presented this item. The board discussed the request and part of the conversation. Mrs. Deborah Morales added to the discussion the reasoning of the amount and commitment by the EDC in comparison to other membership.

Mrs. Rebeca Castillo, EDC Executive Director explained that the focus of the Chamber of Commerce is more business based and the membership along with a higher membership has a higher value to a business than to the EDC. Most of the \$200 level membership benefits are already being done by the EDC and the Chamber is actively collaboration with the EDC and sharing much more on their emails beyond the membership. The discussion also included that there are other funding/collaboration efforts beyond the membership that the EDC is already assisting the Chamber of Commerce with. For example the Business Attractions map the EDC assisted with over \$4000.

A motion to approve the annual renewal membership to the San Benito Chamber of Commerce in the amount of \$200.00 was made by Mr. Adrian Gonzalez. The motion was seconded by Mr. Mario Silva. Voting Aye: Mr. Rene Garcia, Mr. Adrian Gonzalez, Mr. Encarnacion Lopez, and Mr. Mario Silva. Voting Nay: Mrs. Deborah Morales. The motion passed.

Please note that Mrs. Deborah Morales attempted to propose a second motion to recommend \$500 level membership, but the first motion passed.

# 13. San Benito Economic Development Corporation Budget Workshop 1 for Fiscal Year 2021- 2022; (Presented by R. Castillo)

Mrs. Rebeca Castillo presented the preliminary budget workshop for the EDC Board.

She explained the format/template of the budget, the projected funding, total programmed expenditures and how the budget compared to the preliminary draft was more balance now. The proposed FY 2021-2022 annual EDC budget reflected \$1.2 million dollars compared to over \$2.8 million dollars that was originally presented on a prior draft of the preliminary budget. The membership amounts and value of such memberships was addressed by Mrs. Deborah Morales was further discussed. Mrs. Rebeca Castillo will be looking at that line item more closely and provide feedback to the EDC Board and more information as to any updates on the proposed memberships. Mrs. Castillo anticipated that the proposed draft amounts for the FY 2021-2021 EDC Annual Budget will slightly change further and she can possibly identify \$10,000 to \$12,000 in additional savings.
