2. Call to Order (J. Rios)

Mr. Julian Rios called the meeting to order at 5:30 PM.

Miss Katarina Guerra led the pledge of allegiance and Texas flag pledge.

4. Public Comments (K. Guerra /J. Rios)

5. Presentation and Acknowledgement of the San Benito EDC Financial Statements for the period ending June 30, 2022 (E. Rosas)

The San Benito EDC Financial Statements for the period ending June 30, 2022 were presented by Ms. Elisa Rosas, Finance Director.

Ms. Elisa Rosas provided information about an account receivable employees balance. She stated, "it has been there since 2019 and asked the Board of Directors what they want to do since there is an audit coming up. It is a health insurance expense, and the employee was contacted. They have known for a year that they had to pay."

Mr. Julian Rios had stated that the top part of the establishment is used for residential purposes and that is ineligible according to the guidelines. Mrs. Deborah Morales than added that both bids provided were ineligible due to one no longer in service and the other one being self-contracted.

Mr. Julian Rios questions about tenants and asked about where he is going to generate sale tax from. Mr. Julian Rios then states from the guidelines that mixed used buildings are eligible if the ground floor is over 50% commercial use, but at this moment he doesn't have tenants. He is not in compliance with guidelines.

She explained that the committee had met and decided after further review that the application should be denied due to insufficient dollar to dollar collateral and 25% equity that needs to be matched to the loan.
