### 1. Determination of a quorum

Mr. Julian Rios made welcoming remarks. A quorum was determined to be present.

### 2. Call to Order;

Mr. Julian Rios called the meeting to order at 5:33 PM.

# 3. Pledge of Allegiance and Texas Flag Pledge

### 4. Invocation

### 5. Public Comments

No Public Comments.

A motion to deviate from the agenda to address item 7 prior to addressing item 6 was made. Mr. Rene Garcia motioned it first and it was seconded by Mr. Mario Silva. The motion unanimously passed.

7. Consideration & Possible Action on the Community Partnership Grant Application requesting C\$9,113.75 by the Friends of the San Benito Cultural Heritage Museum for the Oral Booth related activities & a historical marker;

Ms. Sandra Tumberlinson, representative from the San Benito Cultural Heritage Museum made a presentation on the request of the Friends of the San Benito Cultural Heritage Museum for the Oral Booth related activities & a historical marker.

A motion to approve the Community Partnership Grant Application requesting \$9,113.75 by the Friends of the San Benito Cultural Heritage Museum for the Oral Booth related activities & a historical marker was made by Mr. Mario Silva. The motion was seconded by Mr. Encarnacion Lopez. Motion carried unanimously.

A motion to return to item number 6 was made by Mr. Rene Garcia. The motion was seconded by Mr. Encarnacion Lopez. Motion carried unanimously.

6. Consideration and Approval of a Resolution by the Board of Directors of the San Benito Economic Development Corporation Approving a financing/use agreement relating to the expenditures of sales tax revenues for various projects; and authorizing other matters in connection therewith;

Mrs. Rebeca Castillo presented the item to the EDC Board of Directors. She explained the request by the City of San Benito to assist with bonds for water related infrastructure improvements and that there was \$137,000 that were recently freed up when the San Benito Police Department bonds related payments had been paid off earlier this fiscal year (2019-2020). She added that this amount was mentioned and a placeholder for consideration of this request was factored during the FY 2020-2021 Annual Budget proposal, which was recently approved.

Mrs. Rebeca Castillo introduced Mr. De La Rosa, City Manager of San Benito and that he was available to answer any questions that they had. Mr. De La Rosa provide the EDC Board with a listing of the proposed lift stations that the funds will be used. The listing also included equipment and other departments items that were being included as part of the bonds issuance, but not part of the EDC's commitment.

Mr. De La Rosa stated that the resolution is drafted so that if pricing comes shorter or longer, the City will have room for negotiating the final terms of the agreement on October 20, 2020.

Mr. Rios asked for the resolution and agreement to reflect that the EDC's commitment will be for "not to exceed \$137,000" and that if the bonds were to be refinanced that it will not be extended past the original terms of the project of 25 years. With 2045 being the ending year of the project.

Mr. Antonio Torres, EDC Attorney stated that this project is a lawful expenditure of a type B.

A motion to approve the resolution approving a financing/use agreement relating to the expenditures of sales tax revenues for various projects; and authorizing other matters in connection therewith was made by Mr. Rene Garcia. The motion was seconded by Mr. Mario Silva. The motion carried unanimously.
